FOOD SHARE PROGRAM PROMOTING SUSTAINABILITY AND CAPACITY BUILDING, FEEDING AMERICA RIVERSIDE|SAN BERNARDINO WORKS WITH OVER 300 PARTNER AGENCIES TO PROVIDE HUNGER-RELIEF SERVICES AND EMERGENCY FOOD ASSISTANCE TO NEIGHBORHOODS THROUGHOUT RIVERSIDE AND SAN BERNARDINO COUNTIES. OUR NON-PROFIT PARTNERS ARE HELD TO A STRICT SET OF GUIDELINES AND GOVERNING PROCEDURES THAT ENSURE FOOD IS DISTRIBUTED SAFELY IN ACCORDANCE WITH STATE AND FEDERAL LAW.
